## **PARENT/GUARDIAN - PLEASE READ THE FOLLOWING VERY CAREFULLY:**

Participation in a C.R.O.W. show is FREE to your family, but there are some requirements. By allowing your child to audition, you are acknowledging that you are aware of these expectations should your child be cast in the show.

- 1) Parents are required to join a committee and volunteer time during rehearsals and performance/tech week. Examples of committees are: fundraising, costumes, props, set construction, green room, cast party, technical theatre (lighting/sound), etc. Please review the committee descriptions carefully. Ask us if you have any questions. We are happy to clarify.
- 2) All cast member families must actively participate in the sales-type fundraiser. This means that you understand that your family will sell physical items in order to help raise funds for this production. If you'd prefer, you may make a donation, instead of participation in the show fundraiser.

**PARENT/GUARDIAN AGREEMENT:** I understand that my child is being considered for a role in *Newsies* presented by C.R.O.W. If my child is cast, I understand that I will be required to volunteer my own time and participate in the show's fundraiser. We have reviewed the rehearsal schedule and have written down any conflicts on this form to the best of our knowledge. I will make sure that my child is on time and will pick up my child promptly when rehearsals are finished. We will comply with all behavior and safety regulations. I understand that *Newsies* will be produced in a professional manner, and that my child may be asked to leave the show at C.R.O.W.'s discretion, if he/she exhibits any behavior related problems or has unexcused absences. I will notify C.R.O.W. immediately should my child need to be late or miss rehearsal for any reason. I understand that my child may not be absent for any reason other than illness/emergency during tech week/performances (April 8-21, 2024).

**HOLD HARMLESS:** I have read, understand, and agree to C.R.O.W.'s Behavior Code of Conduct and Hold Harmless Agreement. I agree to hold C.R.O.W. harmless and know that I am fully responsible for my child's behavior at all times.

**COSTUME MEASUREMENT & FITTINGS/ MICROPHONE AGREEMENT:** If cast in the show, I understand that my child will be measured and/or fitted in a costume by a member of C.R.O.W.'s costume committee. My child may also need to have a microphone put on by a staff member. If my child needs special accommodations or is uncomfortable about being measured or fitted in a costume or having a microphone put on, I will notify C.R.O.W.'s production team to make alternate arrangements.

**PHOTO/VIDEO RELEASE:** My signature below also hereby grants permission for photos and/or videos of my child to be utilized for any purpose by C.R.O.W. in print, on television, and/or online (i.e. – C.R.O.W.'s website/Facebook page). My child's voice may also be used for promotions, events, etc. live or recorded as necessary. There is no expiration date for this release.

**COVID/ILLNESS/INJURY RELEASE:** I know that C.R.O.W. will take every possible precaution to keep my child safe from COVID-19 and all other illness and injury. However, I understand that participation in the show is at my child's own risk. I agree to hold C.R.O.W. harmless from any potential COVID exposure, injury, or illness during the course of the show, and I am fully aware of the risks involved regarding my child's participation in this show.
